Renal Review Implementation Group Meeting

The last meeting was held on October 20th at Stormont buildings. The following points cover the main issues discussed and their outcomes.

- 1. Electricity costs for home dialysis patients. Colin Thompson (NIKPA Chairman) raised the issue of financial assistance to cover the raised electricity bills of patients who have dialysis at home. It has been agreed by the Review Group that electricity costs directly associated with home dialysis would be met in full.
- **2. Vascular Access Targets.** The target to increase patients changing to a fistula from a central venous catheter is looking quite good. Although difficulties still exist:
- (a.) Some patients are reluctant to change to a fistula even though it means a decrease in risk of infection and improved patient outcomes.
- (b.) There are problems with how many fistula procedures could be carried out within a certain period of time due to hospital limitations.

Both of the above are being looked into.

- **3. Live Donor Transplantation.** The waiting time for live donor transplantation remains a major concern. The target aimed for is that no patient should have to wait more than nine months for a living donor transplant.
- **4. Expansion of Antrim Area Hospital Renal Unit.** The Trust is finalising a business case for 20 additional stations. There is a real possibility that this could be provided within the next two years.
- **5. Renal Unit at Causeway Hospital.** Specific recommendations (such as number of stations and number of shifts) have been made on the way forward with the development of a renal unit at the Causeway Hospital.

The 2002 DHSSPS Review of Renal Services outlined proposals for the commissioning of a new renal unit at the Causeway Hospital which would be phased in by 2010.

Rates Reduction Entitlement

"The Disabled Person's Allowance (Rates) is a rates reduction provided by the government in recognition of additional space and facilities required by individuals who are "substantially and permanently" disabled.

The reduction is available in respect to both adults and children and at least one of three conditions must be met:

- You have an additional bathroom or kitchen needed by the disabled person or
- 2. You have a room (other than a bathroom, kitchen or toilet) needed by and predominantly used by that person or
- 3. You have enough space in your dwelling for that person to use a wheelchair used by and required for meeting the needs of the person with a disability. indoors.

(Disability Rights Handbook April 2008 p55)

Renal patients who are, for example, wheelchair users or who meet the above criteria should consider applying even if they receive dialysis in the hospital setting. Those undertaking either Peritoneal Dialysis or Home Haemodialysis will be applying on the basis that a significant portion of their home is given over to treatment and storage.

Forms can be requested from the Rates Collection Agency by telephoning 028 9025 2252 and asking for the Disabled Person's Allowance. If the member or their family is an internet user the form can be applied for on the link: http://www.lpsni.gov.uk/index/do-it-online/request_dpa_application.html. If you wish to download and print a paper copy of the form then go to http://www.lpsni.gov.uk/app_disabled_persons_allowance.pdf.

Once applications have been made there can be a considerable wait until they are assessed and a decision delivered by the Rates Collection Agency. Awards are not automatic but are assessed by visitation by an RCA officer. If the decision is not to award a rates rebate then an appeal can be requested through the RCA."
